Sealed Proposals will be received by **The Montgomery County Board of Education** at the Central Office Boardroom (Auditorium – Ground Floor), 307 S. Decatur Street, Montgomery, AL 36104 until 2:00 PM, Local Time, on **Thursday, January 26, 2023**, for **Minor Renovations & Site Upgrades to The Children's Center** for **The Montgomery County Board of Education** at which time and place they will be publicly opened and read.

An onsite Pre-Bid Conference is scheduled for Thursday, January 19, 2023 at 3:00 PM, Local Time, at The Children's Center School campus located at 310 North Madison Terrance, Montgomery AL 36107. Scope of Work includes minor site upgrades, a new canopy system, mechanical and electrical connections to commercial laundry equipment, minor flooring upgrades. Attendance at the Pre-Bid Conference is highly recommended for all interested General Contractors or Subcontractors intending to submit a proposal.

A cashier's check or bid bond payable to **Montgomery County Board of Education** in an amount not less than five (5%) percent of the amount of the bid, but in no event more than \$10,000.00, must accompany the bidder's proposal. Performance and Payment Bonds and evidence of insurance required in the bid documents will be required at the signing of the Contract.

Bids must be submitted on proposal forms furnished by the Architect (Engineer) or copies thereof. All bidders bidding in amounts exceeding that established by the State Licensing Board for General Contractors must be licensed under the provisions of Title 34, Chapter 8, Code of Alabama 1975, and must show evidence of license before bidding or bid will not be received or considered by the Architects (Engineer): the bidder shall show such evidence by clearly displaying his or her current license number on the outside of the sealed envelope in which the proposal is delivered. The Owner reserves the right to reject any or all proposals and to waive technical errors if, in the Owner's judgment, the best interest of the Owner will thereby be promoted.
